Now this Deed witness that for the purpose of effectuating the said desire the Managing Trustee has irrevocably transferred the said sum of Rs. 1000/- (One thousand only) to the Trustees. The transfer whereof to the Trustees do and each of them both hereby admit and acknowledge being subect to the uses and trust herein after mentioned : -

The Trust shall be called as " SRI RENUGADEVI EDUCATIONAL TRUST"


### 2. Registered Office:

# 3. Board of Trustees

The Name and posting of the Trustees as follows -

### 4. Bank Operation

The Managing Trustee are vested with all the powers to deal with all the matters concerning with the finance and properties of the trust. Bank Account shall be opened in any Nationalised Bank / Schedule The bank accounts opened in the name of the Trust shall be operated either by Managing Trustee or Tressurer, individually, who are the authorised signatories of the Trust.

#### 5. Objects of the Trust:

The trust has been created for Educational and social service purposes and the objects of the trustee:

- a. To establish, maintain, run, improve, develop educational institutions, Academic, Arts, Technical, Medical, Science, Social Educations and hostels, research centres, Universities, without any motive of profit.
- b. To award scholarships, prizes etc., for the poor and deserving students.
- c. To provide and maintain clean and good high class knowledge of education.
- d. To publish books, periodicals and other works without any motive for profit.
- To promote and develop the physical intellectual economic and social welfare and develop local leadership,
   unity of section co—operative and understanding among the rural and urban people
- f. To educate them on the rights and duties of citizenship and to help them to participate responsibly in the life of the nation and to organise them for their economic and social advancement.
- g. Promote, undertake and implement traditional village craft by organising income generation programme involving both production and marketing.
- h.To establish orphanage for children women and aged destitute, widowers, Handicapped, Deaf and blind, Leprosy Insance and crippled childrens.
- i. To accept upon such terms and conditions, donations, subscriptions, and contributions and the like from any government, Local Authority, Corportation, Firms, Company, Syndicates, Associations or other person or persons from any charitable or other institutions either in cash or in other moveable or immoveable property for the purpose of the Trust, provided always that the terms upon which they shall be accepted shall not in any way be inconsistent or repugnant to the any of the provisions contained on these clauses presents and such donations, grants, aids, subscriptions and contributions eligible so received shall be applied for all of the purposes of the Trust.
- j. To acquire by purchase, grit, settlement, will or otherwise any property whether movable or immovable or acquire any rights for the purpose of the trust.



- k. To Construct, maintain, or after any building or wards necessary for the purpose of the Trust.
- To borrow money for the purpose of the trust upon reasonble terms and conditions with the previous written approval of the Board of Trustees.
- m. to sell, improve, manage, develop, exchange, lease or let under lease or sublet, mortgage, dispose of turn of account or otherwise deal with all or in any part of the property of the Trust, with the previous written approval of the trust, further alienation of immovable property shall be done only with prior approval of the Commissioner of Income Tax.
- n. to invest and deal with the monies of the Trust not immediately required upon such securities including shares and debentures in the companies. Firms and in such manner as may from time to be determined by the Board of Trustass in accordance with the provisions of Section 13 (1) & (2) read with Sec 11(5) of the income Tax Act, 1961.
- To raise funds by subscriptions, donations or otherwise for carrying on the objects set forth in this memorandum.
- p. To utilize and spend the income of the trust for Educational and social purposes.
- q. The funds of the Institutions would be utilised only towards the objects and no potions of it would be distributed in any manner to the trustees or persons defined in Sec 13(1) (c) of the Income Tax Act, 1961
- r. To do all such things as are incidental and conducive to the attainment of the objects or any of these. The trust shall not carry on any activity for profit.
- The activities would be carried out within the territroy of India.
- The benefits of subjects, would be available to the general public irrespective of caste, creed, religion or sex.
- Not more than 5% of the income of the Trust/Institution would be applied for any religious purpose or given to religious instituions.
- To undertake such other activities as may be necessary for the promotion of the subjects of the trust.
- 6. On execution of this deed the trustees shall take charge of the said sum of Rs. 1000/- (Rupees one thousaid only) and it will be the CORPUS of the fixed property of the trust and it shall not be disposed of or subjected to any kind of charge for the purpose of meeting the expenses or for carrying out the unanimously by the board of Trustees.
- 7. The Trustees shall stand possessed of the said amount of Corpus and such other properties as may be acquired from time to time by the trust by purchase exchange, grant subscription, endownment, denetion, contribution or in any manner whatsoever (all of which shall be designated as "the Trust Properties" on the trust here in mentioned.
- The Trustees shall have power from time to time to increase or decrease the corpus of the fixed property of the trust and this corpus will not be used in contravention of cl. 5 here in above.
- The trustees shall have power to accept donation either in cash or movable properties either with or without any special conditions attached to it provided it do not contravence ct. 4 therein above.
- 10. It shall be competent for the trustees from time to time to frame, make and enforce all such rules, regulations and/or bye-laws not inconsistent with the express provisions of the trust as the trustees may deem proper for securing and facilitating the administration and management in detail, of the various department relating to the activities and affairs of the trust and convening, conducting and regulating the meeting of the trustees and for appointing sub-committees and generally for the management and administration appointing sub-committees and generally for the management and administration of trust-estate and also from time to time to repeat, eiter.

amend, resigned or add to all such rules, regulations and bye-laws and also to pass resolutions, connection with or any of the said matters at their meeting.

- 11. The Managing Trustee shall have power and authority to appoint or engage and at his discreation remove, dismiss or suspend one or more Secretaries, Treasurers, Supervisors, Cashiers, Accountants, Clerks, Chowkidars, attendants, servants and other officials or employees and persons in permanent, temporary or special service in connection with the work of the trust, trust estate, trust funds and trust properties as may from time to time think fit and to determine either powers and duties and fix their salaries, bonus, or empluments and to require security in such instance and such amounts as the Managing Trustee may think fit. He shall also have power to determine and maintain provident fund, gratuity funds, personal and other funds for any employee and make rules and regulations regarding the same. The secretary shall be entitled to do the above activities and such other activities for the day to day administration of the trust under the supervision and control of the Managing Trustee on the latter's obsence.
- 12. In the course of and for the purpose of the administration of the trust or for the establishment development and conduct of the several institutions comprised therein grants –in-aid from Government are applied for and obtained and if it becomes necessary for the due performance of the conditions of such grants to secure the same by a mortgage or charge of the properties of the trust, the Board shall have the power to create such mortgage or charge on all or any of the trust properties to facilitate such grants.
- The Trustees shall have the powers in general to acquire all things and do all acts necessary to carry out the objects of the Trust.
- 14. The Trustees shall be entitled to reimburse themselves out of the trust estate all expenses incurred in the execution of the Trust or in carrying out theTrust objects and affairs of the realisation, reservation or benefit of the Trust properties. The Trustees shall be entitled to be indeminfied by the Trust properties against the consequences of all lawful acts done by the Trustees in the course and discharge their duties as the Trustees of this trust and all costs, charges and expenses there of.
- 15. Trustees shall not be entitled to any remuneration and shall work in an honorary capacity. The shall however be entitled to receive the out –of packet expenses incurred by them in the course of discharging the duties of the Trust.
- 16. The Trust shall be governed by a Board of Trustees. The Board of Trustees consist of all the Trustees the number of which shall always be not less than two and not more than ten.
- 17. Managing Trustee may at any time invite and receive or without such invitation receive any voluntary contribution/s either from the Secretary or from the trustees or any other persons/s by way of donation, legacy or otherwise. All such contributions shall be treated as forming part of the Trust fund being the subject matter of these presents, provided that it shall always be for the trustees in his absolute discretion to decide whether they should invite and or accept any such contribution and he shall at all times be at liberty to refuse any contributions without giving any reason for such refusal.
- Subject to provisions herein above the Trustees shall not keep with them at any time more than Rs. 1000r- in cash.
- 19. The Managing Trustee or Secretary shall have power to deposit the trust moneys donations and income from them or any portion thereof in any National or Scheduled Bank's either by way of fixed Deposit or in current Account. The Trust money so deposited shall not be withdrawan for any purpose at any time. Only income from them alone should be utilised for the objects of trust.
- 20 The Bank account shall be opened in Nationalized Banks, Scheduled Banks, Private Banks and NBFC etc., Such bank account shall be opened in the Name of the Trust only. Bank accounts may be opened such as S.B. Account, Current Account, F.D. Account, Loan Account, OD Account in any other Account or facilities or any other Account in Nationalized Banks, or Scheduled.

Banks, such all Bank Accounts shall be operated by Managing Trustee and any other authorized person by the Managing Trustee.

- 21. The Trust shall apply for any Loans or facility or financial Assistance, Bank guarantees in Nationalized Banks, Scheduled Banks, Private Banks and NBFC etc., other persons for the purpose attainment of general objects of the Trust or To start and maintained any social Service, Institutions, Colleges, Schools, Medical Colleges, Hospitals, Hostels, any type of educational Institution or Technical Institution.
- 22. The documents for the Loans shall be signed by the Managing Trustee on behalf of the Trust.
- 23. Managing Trustee have borrowing power to execute vehicle loan documentation, building and land mortgage with Nationalized Banks, Scheduled Banks, Private Banks and NBFC etc., for schools and other institutional purpose.
- 24. The trustees shall have power to invest the money in any Government Securities or in any other approved manner and also to invest in such manner as may be directed by the Board of trustees, and from time to time vary the investment in which the trust funds may be invested, all the investments shall be subjected to the provisions of sec 11 (5) of the income Tax Act.
- 25. The trust money shall not be invested with any private individuals or Firms or association of persons or body of individuals.
- 26. For the purpose of carrying out the objects of the trust, the trustees shall have power to acquire by purchase or on lease or otherwise any immovable properties of any tenure and in case of vacant land the trustees shall be at liberty to errect buildings thereon and to do all acts necessary and incidental thereto.
- Any ammendments to the trust deed will be carried out only with the prior approval of the Comissioner of Income Tax /Director of Exemption I any other authority under direct taxes law.
- 28. I shall be lawful for the trustees to pull down, renovate, rebuild, alter adapt, improve and to develop or repair any immovable property Comprised in the trust properties and to extend thereon such moneys out of the trust fund of the income thereof as they may think fit.
- 29. It shall be lawful and competent for the Managing Trustee in his discreation to make dontion from the trust properties and or send the moneys of the trust in his discreation in any other manner to carryout of the objets of the trust and not contracvening cl. 4 herein above.
- 30. The entire control regulations management application and administration of the trust properties whether capital or income, rent, interest or profit of any kind shall be in the discreation of the Managing Trustee.
- 31. Every power, authority prediscreation conferred upon the Managing Trustee shall be execrised or signified either by some instrument in writing to be signed by all the trustees or such of them as may present or by t resolution of the trustees or such of them as may be present there and vote at any meeting of the Trustees.
- 32. Incase of difference of opinion arising among the Trustees and in all matters wherein the trustees shall have discreationery power the opinion of the majority of the Trustees by voting shall pervail and be binding on the majority as well as on those trustees who may not have voted and if the Turstees shall be equally divided in opinion, the matter shall be decided according to the casting vote of the Managing Trustee.
- The meeting of the Board of trustees shall held atleast once in a year but any number of other meetings may be held as and when considered necessary.
- 34. A minutes book shall be kept by the trustees, minutes of the entry into office of every new Trustees and of all proceedings of the meetings of the Board of Trustees shall be entered in the minutes book and shall be signed by the Managing Trustee.

35. Proper and regular books of accounts of all receipts and payments of the trust shall be maintained by the Treasurer.

- 36. On the 31st day of March every year a general account shall be taken of all the liabilities and Asset of the Trust and the Income and Expenditure Account for the whole year and a Balance sheet as on 31st March shall be prepared. The account of the Trust shall be Audited annually by a Chartered Accoutant appointed by the trustees for the purpose
- 37 In case of death, inability, resignation or refusal on the part of any life time Trustees, Managing Trustee, Secretary, Treasurer to act as such the Board shall have power to appoint co-opt a Trustee, Managing Trustee, Secretary, Treasurer in the place of the retiring or deceased Trustees.
- 38. The trust is irrecovable. There is no immovable properties involved in this Trust at present.
- 39. In case of winding up or dissolution the net funds would be transferred to institutions having similar objects and enjoying exemption U/S 11 of the income Tax Act. I would like to Register this Trust at Ami Regitrar Office, Arni.
